In any event, an annulment is an official determination by an ecclesiastical tribunal that what appeared to be a valid marriage in the eyes of the Church was not.

Catholic annulment means that a couple was never married in the sacramental sense. God did not create that unbreakable bond between them because the sacrament of marriage was not actually fulfilled. First, divorce is a civil law decree from the state, whereas an annulment is a canon law decree from the Church. In other words: The state issues a marriage license; and the state issues a divorce decree. The Church celebrates the Sacrament of Matrimony; and only the Church can issue a Decree of Nullity (otherwise known as an annulment). The Church does not believe in divorce.
